CFO offers a varied program including: worship, singing, inspirational sharing, talks, rest, quiet times, prayer time, and great fellowship. You are encouraged to participate as the Lord leads. The CFO experience should enhance your spiritual awareness and commitment to strengthen involvement in your church home.
